Our Pipe Division inspection services

This division centers involves inspection to Mill Inspection (Q.A.) of line pipe including UT, weld, bench, finishing, loading and receiving inspection. Inspection is also offered during all stages of the mill process. We can also provide custom services such as audit to resident inspection.

The cost of pipe inspection services is brought into value once a failure has occurred! For example, an effective line pipe inspection package can cost from \$0.25 to \$0.50 per meter. This inspection cost is probably recovered just by reducing field construction costs. This ensures that an obvious problem is corrected *before* leaving the manufacturing facility.
